7.1 <u>Review of Committee Duties</u> – C. Villafuerte, Bond Counsel (Stradling) Mrs. Plotkin informed the committee that the Board of Education approved a resolution to amend the duties of the Measure ER Independent Citizens' Bond Oversight Committee to charge the committee with the responsibility for reviewing the expenditures of Measure A and Measure EE bond proceeds (disbanding the Measure A/EE Committee).

Mr. Villafuerte, Bond Counsel, Stradling Yocca Carlson & Rauth provided a page-by-page review of the amended and restated committee bylaws/committee duties to provide a better understanding of what is expected of the committee (including the Measure ER project list).

7.2 Bond Expenditures Update – C. Plotkin

Measure ER bond expenditures for October 2017 totaled \$74,138.45. Measure ER bond expenditures for November 2017 totaled \$106,343.75. Measure ER bond expenditures for December 2017 totaled \$124,801.44. Measure ER bond expenditures for January 2018 totaled \$361,688.45. Measure ER bond expenditures for February 2018 totaled \$361.35

7.3 Measure ER Audit Report (FY Ending 2017) – C. Plotkin

An audit for fiscal year ending June 30, 2017 was performed as required. There are two sections of the audit, the financial section and the performance section. On page 12 of the audit report is the final opinion that the District complied with the compliance requirements for the Measure ER General Obligation Bond proceeds.
